Sir,

I am directed to say that Ministry is in process to organize a series of Eye Check Camps for Truck Drivers preferably before or during the upcoming National Road Safety Month, 2022 (i.e. Mid-January, 2022 to Mid-February, 2022) along National Highways across the country.

2. During the camp, eye check-up of the truck drivers having valid Commercial Driving License would be done, they will be given the check-up report and spectacles, where necessary as per doctor's advice.

3. In cases, where spectacles are given, photographs of the concerned driver while wearing the spectacle along with the clear picture of DL in one hand be taken for record. Also an undertaking in the enclosed format (Annexure-I) may be obtained.

4. The duration of camp in a particular place should not be more than 7 days. While selecting the place of camps (i.e. toll plazas, wayside amenities, dhabas/parking, town/city along national highways), it should be kept in mind that the gathering of vehicles does not become a hindrance for traffic movement and large number of drivers can be attended, etc.


5. You are, therefore requested to submit the proposals online (through the Road Safety Advocacy portal of this Ministry). Organizations/Associations other than NGO, may submit proposal off-line directly to this Ministry) latest by 15.11.2021 while including, *inter alia*, the following points: -

- i. Geographical Coverage (location and number of camps).
- ii. Target Numbers Per Day and Total target numbers for the whole period of 7 days.
- iii. Dates and Duration of the Programme.
- iv. Total Financial Implication with item-wise break up and the financial assistance required from this Ministry.

6. The camp should have one eye specialist, and at least one optician and attendant.

7. This issues with the approval of the Competent Authority.
